

IN SUPPORT OF THE FOLLOWING BILLS UNDER CONSIDERATION BY THE JOINT LEGISLATIVE COMMITTEE ON AGING AND INDEPENDENCE

June 24, 2025

Dignity Alliance Massachusetts is pleased to offer our support for legislation under review by the committee today. In particular, we strongly support S481/H796, An Act to establish the office of older adult advocate, and S491, An Act to improve the resilience of older adults and people with disabilities during public health, environmental, and technological emergencies.

• S481/H796, An Act to establish the office of older adult advocate

While Massachusetts was one of the first states to establish a cabinet level office of elder affairs (now called the Executive Office of Aging and Independence), the concerns of older adults extend well beyond the programs within the purview of the Secretary. When the office was established in 1974, the then-Secretary of Elder Affairs was a full participant in the Governor's Cabinet. Although the General Laws (Chapter 19A) still mention the Secretary as part of the Cabinet, recent state administrations have treated the position as subordinate to the Secretary of Health and Human Services. ¹

Even if the Governor were to treat the Secretary of Aging and Independence as a Cabinet member (as the law provides), the limitations on the duties of the position precludes the important role that older adults deserve to play at the highest levels of state government. The Legislature has recognized this lack of effective voice for children, by creating the Office of Child Advocate (C.18C MGL), and for Veterans by creating the Office of Veterans Advocate (Chapter 115B), Both of those positions are relatively independent of the administration and serve as a sort of "inspector general" to address issues that cut across the state bureaucracy and provide a critical role in elevating issues and programs important to their constituencies.

Governor Healey has issued Executive Order 642 Instituting Age-Friendly Practices, with the goal of making Massachusetts state government more age-friendly, and directs all cabinet agencies to provide a list of programs under their jurisdiction that benefit older adults. However, the Executive Office of Aging and Independence has no clear authority to monitor these activities. An Older Adult advocate, that is quasi-independent, would be an ideal office to provide government-wide oversight of the executive order.²

• S491, An Act to improve the resilience of older adults and people with disabilities during public health, environmental, and technological emergencies.

While everyone is at risk during a natural weather-related disaster or similar emergency, older adults can be especially vulnerable during these challenging times. Being prepared in advance can literally mean the difference between survival and death, particularly for those who may have special medical or mobility needs. Older adults often face unique challenges during emergencies due to factors such as limited mobility, medical needs, and isolation. They may rely on a single relative as their main caregiver, but emergencies can happen at any time, and that person may not be available. It is crucial for older adults to have a list of people they can call on and know how to get hold of them. Additionally, having a medical alert bracelet or pendant can be life-saving, especially for those with medical conditions or allergies. Emergency preparedness for older adults involves assessing their specific needs, creating a personalized plan, and engaging their network of family, friends, and caregivers. They should also be aware of the types of disasters that could affect their area and plan how to respond in both evacuation and shelter-in-place scenarios. We recommend that the
